Egyptian Long Distance Subscribers get Free Nationwide Calling in December



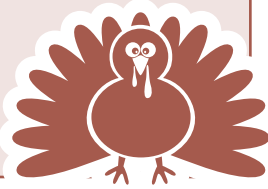
